



## **MEMORANDUM OF UNDERSTANDING**

**Between**

**Buriram Rajabhat University,**

**Kingdom of Thailand**

**And**

**United University,**

**Prayagraj, India**

This memorandum of understanding (MoU) is drawn up and agreed upon to establish the cooperation between Buriram Rajabhat University (hereinafter referred as BRU) located at Buriram Province, Kingdom of Thailand And United University (hereinafter referred as UU) located at Jhalwa, Prayagraj, INDIA.

**Buriram Rajabhat University** was originated from “Buriram Teachers’ College” which was established in line with the needs of government officials and local people in 1971. In 1995, His Majesty King Bhumibol Adulyadej graciously granted it the new name “Rajabhat Institute Buriram”, and in 2004 “Buriram Rajabhat University” was kindly bestowed by His Majesty the King. The university is situated on a beautiful plot of land covering about 475,604 square meters. There are about 800 personnel who energetically work for the benefit of their

university. At present, BRU offers more than 60 fields of undergraduate programs, graduate programs, and doctoral programs with about 12,000 full and part-time students.

**United University, Prayagraj**, sprawls over a lush green campus of more than 200 acres and is the dream venture of United group, which is a large technical education group of Northern India, having its institutes in Prayagraj and Greater Noida. Started in 1997. United Group already has nine well- established institutes and about 10,000 students are enrolled. Eligible courses of the Institutes have been already accredited by the National Board of Accreditation, AICTE, New Delhi. It has about 7000 alumni base, and the Group is now focusing on enhancing the academic standards adopting various means including collaborations.

#### **ARTICLE-I PURPOSE**

The purpose of this MOU is to enable cooperation between BRU and UU for enhancing academic standards and research through faculty exchange, student exchange and running joint programme.

#### **ARTICLE-II SCOPE**

The activities under the scope of this MOU are:

1. Offering degree, Diploma & Certificate programmes jointly.
2. Exchanging students and faculty between BRU and UU for short and long duration academic and research activities
3. Taking up joint research and consultancy projects.



### ARTICLE-III DURATION, TERMINATION & AMENDMENT

1. This MoU will be effective from the date of Signing by both parties up to a period of five years, and may be subjected to extensions by mutual consent of the parties in writing.
2. Either party may terminate this MoU by giving three months advance notice in writing to the other party.
3. The provisions of this MoU may be amended at any time with the mutual consent of the Parties in writing.
4. The amendment, termination and expiration of this MoU will not affect the terms of activities ongoing at the time of notification of amendment, termination and expiration unless otherwise agreed upon between the parties.

### ARTICLE-IV SPECIAL PROVISIONS

1. Each party will consult with and take approval of the other party to use the latter's name, the names of the latter's officials/faculty members, and the logo for the activities under this MoU, and dissemination of results, on a case-by-case basis.
2. Modalities of each type of collaboration, associated activities and financial aspects shall be mutually agreed upon on a case-by-case basis in separate Memorandum of Agreements (MoA).
3. Keeping in view the present pandemic situation the physical visit of the students/faculty on either side, would be strictly governed by the then present travel conditions/regulations of both the countries and upon the mutual acceptance of both the parties.

4. The two parties will consult with each other and attempt to resolve disputes or misunderstandings that may arise in the administration of this MoU or any subsequent associated agreement informally.




